- The search for the CME chair has been terminated by the Provost due to the budget situation.
- The library is having listening sessions on what they should be prioritizing. There is a meeting from 2-3pm on Friday (Oct 18th). It would be good to have someone from CoE representing the college. It's at the Library, room 110 on Friday, October 18th.

### Kyle Bosch

• Discover NDSU will be happening this Thursday and Friday. This is the largest high-school recruiting event held by NDSU. There will be hundreds of students and parents touring the campus. Let's welcome them to NDSU.

- The next distinguished lecture series (Tuesday, October 29th) will be Paul Dlugosch: a 1989 NDSU ECE graduate. Presently he's the president of Natural Intelligence Semiconductor. He'll be speaking Tuesday 3:30pm, FLC 124 on Neuromorphic Computing.
- Grant Awards:
  - Alan Kallmeyer and Chad Ulven \$150,000 from PPG Industries for the design and development of durable adhesive joints.
  - CoE faculty were awarded 26 grants from ND EPSCoR for equipment, student travel and research.

- The Strategic Planning Committee has been meeting. The goal is to have something by the end of the year

- NDSU Budget (Glower). NDSU's enrollment is down 600 students, resulting in a drop in tuition of \$5.5. This is due to
  - Fewer transfer students
  - Fewer international students, and
  - Fewer Minnesota students.
