(Kallmeyer): Construction of the new Offerdahl building is underway. Construction will be ongoing throughout the winter. At present, construction is right on schedule.

On a second topic, President Trump issued an executive order restricting funding related to DEI efforts. This really slows things down as every purchase and every new hire has to be reviewed to make sure it does not conflict with this executive order.

On a positive note, a temporary restraining order was issued by a judge last Friday. This means that this review is no longer required - for now. This also means that faculty with federal grants can proceed as normal for the time being. Until otherwise noted, faculty can continue to spend on their federal grants.

Dr. Cook also mentioned that, since we don't know how long the restraining order will last, all faculty are strongly encouraged to submit all eligible expenses in a timely manner.

Note that the executive order is specific to DEI. If you hired graduate students who are working on technical topics, there should be no problems. If, on the other hand, you have tasks or objectives that relate to DEI - such as tasks that specifically focus on

expansion to underrepresented groups or diverse populations - then you may want to put a hold on these tasks for the long term.

On another positive note, Dr. Jeong has accepted the position of interim chair for Mechanical Engineering. A big thank you to Dr. Ulven for his work as interim chair as well as for Dr. Jeong for taking on this new responsibility.

(Le): A second concern is with Inter-Library Loan (ILL). It takes 4-5 days to get a paper through ILL. This delay propagates if going through a sequence of papers. A survey will be sent out get feedback from faculty related to ILL to see how widespread this problem is as well as to solicit suggestions for solving this problem.
